MISSION

Anti-Ragging Committee to ensure compliance with the provisions of Regulations as well as the provisions of any law for the time being in force concerning ragging; and also, to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

OBJECTIVES:

The main objectives of this committee are as follows.

- The Anti-Ragging bearers work under the supervision of Anti Ragging Committee and to engage in inspecting places like Buses, Canteens, Classrooms and other places of student gathering
- In designing strategy for curbing the Menace of Ragging in the college.
- Conduct awareness programmes in the campus on a regular basis.

FUNCTIONS:

- Formed Anti- Ragging Committee consisting of senior faculty and headed by principal.
- Committee has taken steps and allotted duties to all the staff members at almost all areas in the college (i.e., canteen, parking places, different blocks, play grounds etc.) and ensure that at least one faculty member will be present at any particular time at all the location to avoid ragging activities.
- Committee has taken precautions to avoid ragging activities at other locations like bus Stops and given instructions and appointed student volunteers and secrete informers at various boarding points.
- Wide canvassing about anti ragging, is being done in the forms of flexes, posters and boards in college premises and surrounding areas where there is a chance of ragging.
- Grievances & Redressal committee is also made a part of these anti-ragging activities.
- Many awareness programmes about anti-ragging will be conducted by anti-ragging committee in the form of meetings.

ROLES & RESPONSIBILITIES:

- To ensure compliance with the provision of UGC regulation 2009 at the institute level.
- To monitor and oversee the performance of Anti-Ragging committee in prevention of ragging in the institution.
- To publicize to all students about the prevention directive and the actions that can be taken against those indulging in ragging.
- To take necessary measures for prevention of ragging within the campus.
- To consider the complaints received from the students, to conduct enquiry immediately and to submit are port to the Anti- Ragging Committee along with punishment recommended for the offenders.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments:

1. Cancellation of admission.
2. Suspension from attending classes.
3. Withholding/withdrawing scholarships/fellowships and other benefits.
4. Debarring from appearing in any test/examination or other evaluation process.
5. Withholding result.
6. Debarring from representing in institution in any regional, national or international meet, tournament, youth festival etc.
7. Suspension/expulsion from hostel.
8. Rustication from the institution for a period ranging from one to four semesters.
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Collective punishment: when the persons committing the crime or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

As per guidelines laid down by Hon'ble Supreme Court to fight the menace of ragging in Educational Institution the following committee has been formed to keep a continuous watch and vigil over ragging and promptly deal with the incidents of ragging, inside and outside the campus.

The students and faculties are informed to,

- Follow UGC Regulations on curbing the menace of ragging
