In this connection, the following Points are agreed upon:

#### 1. Objective

The overall objective is to provide training to the students of BITS College, in the predesigned courses, and support students on a continuous basis in order to make the students industry competent.

#### 2. Recitals

- a. IGIAT is in the business of providing Training and Consultancy Services and other allied business for its Clients worldwide with a vision to become a "Nerve Centre of Industry" for empowering society through advanced technologies and a mission to provide high quality, employment-oriented training & qualification, consultancy and related services in advanced technologies, aimed at making Industry globally competitive and at improving employability of technical personnel including the disadvantaged groups of the society.
- b. BITS College was established with a vision of "To become a leader in Engineering, Technology, Science and Management education by building the talent of youth into dynamic professionals". It persistently seeks and adopts innovative methods to improve the quality of higher education on a consistent basis
- c. The purpose of this agreement is with reference to defining the areas of cooperation, benefiting both the BITS and IGIAT.

#### 3. Scope of Agreement:

IGIAT:

- IGIAT to liaison with BITS for providing training to the students and come up with strategy to deliver tailor made courses.
- IGIAT to provide the BITS, the methodology and content of the training for the above interaction.
- IGIAT will provide training on the specified list of Courses to the students and faculty.
- IGIAT will bring latest software and advanced hardware training Kits to BITS for trainings.
- IGIAT will organize Seminars/Workshops at BITS with National and International Experts in the advanced technologies.

#### BITS:

- BITS will identify and provide 30 students per batch.
- BITS would set up a BITS- IGIAT Technology Center in the college campus by exclusively naming as above and making available:
  - One furnished Lab/class room with minimum 30 Systems and audio-visual aid.

However BITS can use this lab in all the other free timings.

#### 4. Training Support & Methodology

Training shall be arranged at the BITS premises.

VISAKHAPATNAM

- IGIAT shall provide all support needed for imparting the necessary training to the students of BITS.
- Training is expected to be completed in one academic year.
- Each training program of specified duration will be carried out for two hours on all working days in a week.
- IGIAT and BITS will jointly certify the participants of training programme after successful completion.

#### 5. General Agreements

- Both the parties agree that no action / failure on either behalf to act relating to the above proposal will give raise to / serve as the basis for any claim, obligation or liability on either side.
- The trainers of IGIAT are not responsible for any damage / malfunction of hardware or computer system in the BITS labs during the training period.
- The labs identified for training has to be looked after by the respective lab in-charge of the college.

- Neither party shall issue any press release, public announcement or other such disclosure concerning this Agreement without the other party's prior consent as to such release or announcement.
- This Agreement may not be amended without the prior written consent of both the parties.
- Termination: Either party can cancel or terminate this Agreement unilaterally (and without reason), by giving an advance notice of three (3) months to the other.
- This agreement will be affective for three years with affect from the date of signing.
  However, IGIAT anticipates participation of minimum 50 numbers of students from BITS in
  one or more courses/Internships/Projects towards continued association with financial
  benefit duly mentioned within this MoU.

  - Course fee can be discussed and decide from time to time on mutually agreed basis.
  - BITS fully understands that the same is a fair estimate of the expenditure incurred by IGIAT for designing & developing the program content, acquiring the necessary principal licenses and for providing lectures by National & International experts in the current technologies.
